- 166. Comments from Parish Council/Planning Committee –

The Parish Council had sought legal advice from EALC regarding Chelmsford City Council's position on Neighbourhood Plans. It was perceived that Chelmsford City Council is incorrect in their approach to Neighbourhood Plans only being relevant to developments of 100 houses or less.

169. Analysis of Residents' Questionnaire

JB had completed the statistical summary which was circulated. This was perused and members agreed for DC to add the summarised comments, where applicable. KH will analyse the map section of the questionnaires and complete a summary for questions 19 and 20.

170. Update on Stakeholders' Survey

271 surveys had been emailed or posed – 7 replies had been received by the deadline (14.8.17).

Bloor Homes and Strutt & Parker would like to meet with the Steering Group. Members agreed to initially meet with them (separately) to see what they have to say. Members to discuss agenda before meetings.

171. Update on Meetings with Education Dept. and Broomfield Hospital

It was reported that the Broomfield Place development may not now go ahead because it is understood ECC is likely to propose expanding the current Primary School on its current site, rather than building a new school on the south side of School Lane.

As agreed at the last meeting, JB and GG will meet ECC School Places Planning Officers and CCC shortly to discuss options for the overall provision of school places (**not** specific plans for the current Primary School) as these are so important for the neighbourhood plan.

172. Transport/Traffic Issues

The Preferred Options of the Local Plan has been completed which includes the north of Woodhouse Lane site (Bloor Homes) and Broomfield Place. The next stage is the Pre-Submission Document (published end of September) and is expected to include the north of Woodhouse Lane site but not the Broomfield Place site and includes a further Traffic Study. A meeting will be requested with ECC Highways re the traffic study to better inform the development of the neighbourhood plan on this vital issue.
