a) Policies

Photographs of various areas were discussed and there appeared to be only a small amount missing. PM and DC were requested to choose the best views from their stock of photos taken last year. To avoid confusion, it was suggested that views should be numbered before sending to JB in batches for final decision.

Updates on:

36.20 Site Assessment Exercise

A document outlining the rationale for deciding which sites to consider further had been circulated. It was agreed that the 2 small employment sites that had been put forward were not needed. The document was then approved. It was noted that in due course an introduction to the document will need to be drafted before it can be published.

37.20 Community Aspirations

It was felt that, although it is easy to put forward community aspirations, what we actually need to show is "how" and "what" we can do to achieve them. Discussion took place and JB said he would draft a list of what we may be able to achieve, omitting those items we cannot. The Group were requested to email JB with any further comments or suggestions.

Agreement in place for second part of the cycle path feasibility study.

JB said he has not yet had a chance to contact the agents but will do so soon.
