**GENERAL NOTICE OF REGISTERABLE INTERESTS**

<p><b><u>Other Pecuniary Interests</u></b>  <b>(Required under the Code of Conduct not by legislation)</b></p> <p><b>Members are only obliged to register their own interests under this heading and do not need to include the interests of husbands/wives/civil partners or others</b></p>

<p>2. Any gift, benefit or hospitality with a value in excess of £50, which you have accepted as a Councillor from any person or body other than the Council, including the name of the donor.</p> <p>NOTE- A notification is required within 28 days of the receipt of any such item, so this is an ongoing requirement.</p>	

I recognise that it may be an offence under the Localism Act 2011 to:-

- (1) omit information that ought to be given in this notice;
- (2) provide information that is materially false or misleading;
- (3) fail to give further notices in order to bring up to date information given in this notice after my re-election or reappointment or to fail to declare a disclosable pecuniary interest that I acquire after the date of this notice and have to declare under the provisions of s. 31 (2) Localism Act 2011.

I also acknowledge that it may be a breach of the Code of Conduct to:-


- (1) omit information that ought to be given in this notice;
